For a juristic shareholder, a photocopy of the juristic entity's Affidavit which was issued no more than three months previously and certified as a true copy by authorized person(s) of that juristic entity and a certified true copy of valid identification card or governmental officer identification card or driving license or passport or alien identification card of shareholders or authorized person(s) of that juristic entity shall be attached.
- In event that shareholders have changed their title, name or surname, a true copy of evidence of the change certified on each page shall be enclosed.
- Other supporting document(s) which will be beneficial for consideration shall be certified as a true copy on each page by shareholder(s).
