

Development of Board Members and Senior Executives

The board has a policy to promote and facilitate continuous development and capacity building for directors and executives. This aims to enhance their knowledge and abilities, and to seek understanding of their responsibilities and the ever-changing management approaches. Activities include orientation for new directors, site visits within the company or group, study tours to other organizations, training sessions, seminars, or participating in seminars organized by various agencies such as the Thai Institute of Directors Association, the Stock Exchange of Thailand, the Securities and Exchange Commission, as well as knowledge exchanges among directors, hiring consultants, and organizing Board Retreats.

Currently, five directors have attended IOD's Director Certification Program (DCP) and six have attended its Director Accreditation Program (DAP). One hundred percent of the 10 directors have passed the training course on IOD's directors. In this regard, the Company has continuously provided the Board with useful information, seminars, and training sessions. along with informing the directors of information related to good practices according to the principles of good corporate governance.
