The executives and employees are adhere to practice, covering business operations with stakeholders with transparency, honesty, and fairness, in parallel with sustainable business operations. The scope of the Company's supply chain management covers the Company's business operations in term of project development and construction processes, procurement of raw materials, equipment, and hiring contractors for the design and construction, including property management, and the organization, handling the procurement processes of materials, equipment, facilities and hiring contractors for providing services. The Company has set policies and guidelines as follows;

- 1. Defining supply chain management strategies, ensuring that management is transparent, fair, verifiable, responsible and it complies with laws, regulations, relevant requirements in countries in which business is conducted. The international guidelines are also consistent with the business strategy for the maximized benefits and sustainability mutually.
- 2. Defining the process of screening suppliers before contracting in each project with the following criteria;
 - 2.1 Company's reliability and financial management capabilities
 - 2.2 Technical and technological innovation
 - 2.3 Management and consideration of the impacts on safety and environment, occupational health, and quality of work.
- 3. Establishing the criteria and measures on environment and human rights in the employment contract and the FPT Code of Conduct for Suppliers.
- 4. Establishing a mechanism for evaluating the performance of suppliers. The evaluation is random by the responsible department, with a registration of the manufacturer/contractor In accordance with the procurement policy. And the status of those manufacturers/contractors will remain in the next year.
- 5. Procurement and contracting process is transparent, equitable, and fair for both parties in accordance with the procurement policy and the bidding process.
- 6. Establishing Contract Value Assessment and Spend Analysis to prevent any damage that may occur to the business and reputation of the Company.
- Cooperating to develop suppliers to become business partners (Partnership) by developing their capability through doing business based on listening and providing feedbacks.
